Attention: WHO Pandemic Treaty being pushed in 194 countries

Honourable Member of Parliament,

We write to you with grave concern about the ongoing discussions regarding the latest **World Health Organisation CA+ (the Pandemic Treaty)** and the proposed amendments to the **International Health Regulations (2005)** which are threatening the removal of our national sovereignty since this Treaty and these Regulations are legally binding and would therefore take precedence over the constitution of all 194 members of the WHO.

We elected you as our representative and guardian of our Constitution and we fail to understand how there is no indication of what stance you intend to take in the face of such a threat to the Sovereignty of our country. With this letter, we are asking: how much Malta as a Member State is already compromised and whether it will be expected to submit to the WHO 's power grab against the will of the people?

Our forefathers worked hard to achieve our autonomy from foreign interference, and we are now being forced to submit ourselves to an undemocratically elected and unaccountable institution which receives most of its funding from private donors. It cannot be voted out in the event of misconduct and is not free in its actions because it is dependent on its sponsors. The WHO is heavily influenced by the World Economic Forum (WEF) and funded mainly by pharmaceutical industries like the Bill and Melinda Gates Foundation and the Gavi Alliance (also of Bill Gates), Germany, the USA and the EU Commission; 84% of its funding is therefore mainly from private entities and contributors and not from member states. These are global players with tremendous geo-political and financial interests which do not align with the interests of our country and the well-being of our nation. The WHO is not primarily committed to scientific knowledge and the well-being of the people but to the interests of certain partly private actors.

In the (largely secretive) negotiation process of the World Health Assembly (WHA) which is the decision-making body of the WHO, no national or international public comment or vote was ever sought, since the public is not considered to be a relevant 'stakeholder'. Unlike the proposed new Pandemic Treaty, which must be scrutinised by Parliament before being ratified by the government, the IHR (International Health Regulations of 2005) is an instrument of international law which is legally binding in 194 countries. Any adopted amendments will require no parliamentary scrutiny or votes; in other words, we the public would be at their total mercy.

Most of the proposed amendments (307 in the working draft) will likely be adopted in the 77th WHA meeting in May 2024. Each country must opt-out to prevent some or all of the adopted amendments applying to them. No response will be considered as a Consent.

In May 2023 the Pandemic Treaty and the IHR amendments were discussed during the 76th World Health Assembly in Geneva. Dr Abdullah Assiri, Co-Chair of the IHR, argued that *“the world requires a different level of legal mandates prioritising actions that may restrict individual liberties mandating and sharing of information, knowledge and resources and providing funds for control efforts.”*

In the previous 75th WHA meeting of May 2022, the period within which a member state can reject future amendments was significantly reduced from 18 to 10 months and the total time of when these amendments would enter into force was halved from 24 to 12 months. This time restriction will significantly impede the normal democratic process for lobbying groups to raise awareness and apply political pressure and thus increase the chances of dangerous and undesirable amendments slipping through, unnoticed by the public and politicians until it is too late.

The timeframe for our government to **reject** any/all of the five amendments adopted in May 2022 is **this coming November 2023**. To reject an amendment, our government is required to actively **invoke Article 61** of the existing International Health Regulations before the deadline passes. **Inaction by the Government until the deadline passes is all that is required for these amendments to become binding under international law.**

We are urgently calling on our government to actively **reject** the adopted amendment to **Article 59** (*which deals with the entry into force; and the reduction of time for the period of rejection or reservations*). With many of the proposed IHR amendments the current ‘Advisory’ status of the WHO is upgraded to an ‘Emergency Guidance’ status which is legally binding on member states and their people and it simultaneously removes the IHR clause, which requires the WHO to uphold **‘full respect for the dignity, human rights and fundamental freedoms of individuals.’** **This is of major concern.**

Other proposed amendments empower the WHO Director General (currently the controversial Dr Tedros Adhanom Ghebreyesus), who has no medical qualifications, is unelected and unaccountable, to single-handedly declare a Public Health Emergency of International Concern (PHEIC), the definition of which could be expanded to include ‘potential’ as opposed to ‘actual’ harm. With this Treaty, the WHO will gain supreme authority and more power than they had in the previous pandemic, where other interests would take precedence over our human rights and freedoms.

Adoption of these amendments and the ratification of the new Pandemic Treaty, would result in a highly significant change to global public health governance, permanently undermining, even **removing national sovereignty** in a health emergency (planned, perceived or otherwise) and handing it over to the WHO (and potentially their sponsors and funders).

Further amendments threaten free speech and seek to increase censorship of differing opinions by mandating systematic global collaboration to counter dissent to official governmental or WHO guidance, turning our nation into a totalitarian state. **This massive overreach by the WHO requires a swift, effective and robust response from the Maltese government whose primary duty is to protect our hard-won autonomy, the health and freedoms of the Maltese citizens.** We cannot allow an Institution which is unelected by the people to declare an emergency based on a mere suspicion of potential risk.

During the recent 3rd Covid 19 International Summit organised by a number of European Conservatives and Reformists (ECR) at the European Parliament on the 3rd of May 2023, the mismanagement of the entire Pandemic by the WHO was clearly highlighted. The speakers were respected professionals from all around the globe who highlighted the scientific, social, medical and legal statistics and findings of the last three years (*see annex for additional information and references*).

In view of the above, the World Health Organisation (WHO) has completely undermined our trust in its capacity as an international advisory body and we as a country, cannot allow them the responsibility and the power to high jack our sovereignty at any time they deem fit. We ask you to consider: the devastating effects of the measures that WHO imposed on our Country; the lockdowns and forced isolation of the elderly; the psychological damage on adults and children alike; resulting in breakups of families and relationships; the mental health problems and suicides that they provoked; the loss of income, reduced wages and poverty to many; collapse and closure of small Businesses; the delayed visits and operations resulting in more health emergencies and deaths; not to mention the restriction of movement, of travel even to our sister Island. Their mismanagement of this so-called pandemic negatively impacted our Economy and the Wellbeing of us all. A Tree is judged by its fruits and the WHO have plans to repeat this nightmare they have put us through presumably for our safety. Further information can be found in the presentations given at the abovementioned Summit. May we repeat that the WHO is not a democratically elected organisation and those who make decisions cannot be held responsible. In a democracy, policy makers should be democratically elected and be held accountable accordingly. We therefore do NOT acknowledge them or any agreement signed previously with the WHO without the people's informed consent.

If the Maltese parliament ratifies this WHO Treaty, it will: completely override our Constitution; remove the power of our Parliament; and consequently remove all our human rights and freedoms. Without the informed consent of the People, this decision becomes an **act of treason** against the Maltese Nation.

Our Constitution is sacred to every Maltese citizen and should not be changed in any way to gratify the wishes of the WHO. It is possible that during the previous pandemic you were scared, possibly tricked, potentially unaware or maybe you failed to realize the gravity of your actions as an MP.

We therefore kindly ask you as our representative that you present a motion in Parliament to **invoke Article 61** before the deadline passes and to **revoke Article 59** drawn up by the IHR (*International Health Regulator*) to block these unlawful measures for the common good of all our nation. **If you ratify this Pandemic Treaty or if you do nothing and allow the amendments to the Regulations to happen through your inaction, these measures will no longer be guidelines but will become laws.** Unlike the WHO, you cannot deny accountability for wilful negligence and misconduct in knowingly breaching the Constitution of Malta and failing to serve the people of Malta. We therefore ask you **to stand by what is Right for the Good of our Nation.**

Annex:

The professional speakers at the **3rd Covid 19 International Summit** held at the European Parliament on the 3rd May, 2023, raised serious doubts about the integrity of the WHO and their handling of the last pandemic:

❖ Dr David E. Martin:

Dr. Martin stated that the WHO was totally aware of the experimentation done with viruses on animals by the University of North Carolina Chapel Hill in order to weaponize and target any one individual, (better known as 'Infectious Replication Defective'. Dr Martin had made a presentation in exactly the same place in the European Parliament 20 years previously, warning the world of the extreme dangers of this manipulated so-called virus and further stated that (although there was a moratorium) Dr Anthony Fauci was being financed by the American Government at the NIAID, to manufacture *a gain of function* virus in the Wuhan Lab. in China.

Dr Martin stated that in 1990 Pfizer obtained control of the Covid common cold virus and modified it by inserting the spike protein and simultaneously creating a vaccine as an antidote. However, they discovered that the vaccine did not work and never could be effective, because the virus mutated too quickly. There are well over 1,000 publications to prove this fact. **It is highly improbable that the WHO was unaware of what was going on.** Dr Martin concludes that no pharmaceutical company should ever again be permitted to manipulate science; ever fund the WHO; manipulate and hijack science for profit and to the detriment of human health; and that the pharmaceutical companies should be held 100% accountable for any damages inflicted by them.

❖ Dr Pierre Kory stated the following:

- Under the auspices of the WHO the world was **pathologically manipulated**, which is a crime against humanity.
- Big Pharma needs to disconnect from WHO because they are the principal employer and funder and therefore have great conflict of interest.
- The WHO have always had no objective investigators in their camp to do any independent research.
- In fact, big Pharma had enough leverage power to block learned publications on Ivermectin and Hydroxychloroquine in the renowned Lancet Journal. They then resorted to publicizing misinformation in the same journal, to discredit the two treatments mentioned above and then to promote with the blessing of the WHO, Remdesevier which was well-known to kill its host.
- Both Ivermectin and Hydroxychloroquine which were cheap and given over the counter, were banned because of the bad publicity promoted by the WHO.
- It took ten months of deliberation before it was proven that there was deliberate disinformation about Ivermectin and HD, but it was too late as countless numbers had died.
- The WHO were **fully aware** of the efficacy of these two medical treatments yet were happy to ban them to promote the deadly Remdesevier and pave the way for vaccines, with the help and manipulation of the world media.
