Attention: WHO CA+ (Pandemic Treaty) being pushed in 194 countries

Hon. Dr George Vella, President,

On Independence Day, we write to you with grave concern about the potential conflicts facing both Dr Abela, the Prime Minister and Dr Fearn, Deputy Prime Minister & Minister for Health.

The concern for Dr Abela, is in regards to the decisions he is making in his dual roles as Prime Minister of Malta and a member of European Council.

The European Council has been actively advocating for a power grab by the World Health Organisation (WHO) including proudly publishing its Conclusions on 17th November 2020 whereby it states its intention to have a "leading role in an inclusive process aimed at strengthening global health security and the WHO, in particular the latter's capacity for preparedness and response in health emergencies".

In the same published Conclusions the European Council goes on to recognise the challenges that the WHO faces, the first of which is "transparency" as well as "those relating to its response to the current pandemic". It then stresses the importance of strengthening "the organizations' independence, normative work, technical capacity, accountability, efficiency, effectiveness and transparency".

We put it to you that the European Council, knowing the WHO was not fit for purpose, has continued to promote and support a failing incompetent institution and has actively sought to further empower the WHO, an unelected and unaccountable institution with "privileges and immunities as may be necessary for the fulfilment of its objective and for the exercise of its function in every Member State" included in its Constitution.

In his capacity as a member of the European Council, Dr Abela will be responsible for the recommendation of the adoption of proposed amendments to the International Health Regulations 2005 (IHR) and the approval of the World Health Organisation (WHO) proposed CA+ (aka Pandemic Treaty).

We are concerned that his decisions have been in conflict with his responsibility as Prime Minister for protecting the Constitution of Malta, and the health & freedoms of her people.

The concern for Dr Fearn arises from his dual role having recently been appointed as President of World Health Assembly 77 in May 2024. In his capacity as President of WHA77 he will be responsible for the adoption of proposed amendments to the International Health Regulations 2005 (IHR) and the approval of the World Health Organisation (WHO) proposed CA+ (aka Pandemic Treaty).

Each of these decisions referred to above, should they be adopted/approved will result in a highly significant change to global public health governance, permanently undermining, even removing national sovereignty in a health emergency (planned, perceived, simulated or otherwise) and handing sovereignty over to the WHO (for the benefit of their sponsors and funders).

We are concerned that Dr Fearne, in his capacity as Deputy Prime Minister & Minister for Health, should be focussed on protecting the Constitution of Malta, and the health & freedoms of her people.

We cannot allow an Institution, which is unelected by the people, to declare an emergency based on a mere suspicion of potential risk and to threaten our health and freedoms. The WHO is not fit for purpose and is not a democratically elected organisation and those who make decisions are not accountable and therefore cannot be held responsible. In a democracy, policy makers should be democratically elected and be held accountable accordingly.

Unlike the WHO, you cannot deny accountability for wilful negligence and misconduct in knowingly breaching the Constitution of Malta and failing to serve the people of Malta. We therefore ask you to stand by what is Right for the Good of our Nation.

Silence is complicity.

We require a response by 28th September 2023 after which we will publish this letter and inform all residents of Malta that you have full knowledge and awareness of the threat to Malta and her people.
