Attention: WHO CA+ (Pandemic Treaty) being pushed in 194 countries

Honourable Member of European Parliament,

On Independence Day, we write to you with grave concern about the ongoing discussions regarding the World Health Organisation (WHO) proposed CA+ (aka Pandemic Treaty) and the proposed amendments to the International Health Regulations 2005 (IHR) which are threatening the removal of our national sovereignty and the undermining of the Constitutions of all 194 members of the WHO.

We elected you as our representative and with this letter, we are asking: What action will you take to protect Malta from the WHO's power grab?

Our forefathers worked hard to achieve our autonomy from foreign interference, and we are now being forced to submit ourselves to an undemocratically elected and unaccountable institution, which receives most of its funding from voluntary contributions. It cannot be voted out in the event of misconduct and is not free in its actions because it is dependent on its sponsors.

The WHO is heavily influenced by the World Economic Forum (WEF) and receives significant funding by pharmaceutical industries like the Bill and Melinda Gates Foundation and the Gavi Alliance. These are global players with tremendous geo-political and financial interests, which do not align with the interests of our country and the well-being of our nation. The WHO is not primarily committed to scientific knowledge and the well-being of the people but to the interests of certain private actors.

The EU is the 2<sup>nd</sup> biggest non-member donor to WHO! The EU then instructs the 27 countries, which are member states of WHO, on how to vote and what to support. Through this you are potentially complicit in the WHO power grab and the undermining of our Constitution and our sovereignty.

At the 75th World Health Assembly meeting in May 2022, the period within which a member state can reject future amendments, was significantly reduced from 18 to 10 months and the total time of when these amendments would enter into force was halved from 24 to 12 months. This time restriction will significantly impede the normal democratic process for lobbying groups to raise awareness and apply political pressure and thus increase the chances of dangerous and undesirable amendments slipping through, unnoticed by the public and politicians until it is too late.

The European Parliament instructed all members to support the adoption of these amendments and continues to be supportive of the WHO power grab.

You have received, by email, on 12 September 2023, a copy of the letter sent to all Members of Parliament in Malta, bringing to their attention their obligation to act in the best interests of the people of Malta.

## WHO CA+ (Pandemic Treaty) being pushed in 194 countries

The ongoing discussions regarding the 300+ proposed amendments to the IHR and the proposed new Pandemic Treaty, and the overwhelming support of the EU for both matters, in order to get a seat at the table is deeply worrying.

The adoption of the amendments (or the failure to reject them) and the ratification of the Pandemic Treaty would result in a highly significant change to global public health governance, permanently undermining, even removing national sovereignty in a health emergency (planned, perceived, simultaneous or otherwise) and handing sovereignty over to the WHO (and potentially their sponsors and funders).

Further amendments threaten free speech and seek to increase censorship of differing opinions by mandating systematic global collaboration to counter dissent to official governmental or WHO guidance, turning our nation into a totalitarian state.

We cannot allow an institution, which is unelected by the people, to declare an emergency based on a mere suspicion of potential risk and to threaten our health and freedoms.

To reiterate, the WHO is not a democratically elected organisation and those who make decisions are not accountable and therefore cannot be held responsible. In a democracy, policy makers should be democratically elected and be held accountable accordingly. We therefore do NOT acknowledge them, or any agreement signed previously with the WHO without the people's informed consent.

It is possible that during the previous pandemic you were fearful, possibly tricked, potentially unaware or maybe you failed to realize the gravity of your actions as an MEP.

If you instruct the ratification of this Pandemic Treaty or if you do nothing and allow the amendments to the Regulations to happen through your inaction, these measures will no longer be guidelines but will become laws. Unlike the WHO, you cannot deny accountability for wilful negligence and misconduct in knowingly breaching the Constitution of Malta and failing to serve the people of Malta. We therefore ask you to stand by what is Right for the Good of our Nation.

Silence is complicity. You will be judged by your actions (and inactions) in June 2024.

We require a response by 28<sup>th</sup> September 2023 after which we will publish this letter and inform your voters that you have full knowledge and awareness of the threat to Malta and her people.
