Honourable Member of Parliament.

We wish to bring to your attention our increasingly grave concerns regarding the public disorder spreading uncontrollably throughout Europe, with local demonstrations already taking place within our shores. Should this movement join with the simultaneously growing global outrage regarding vaccine contracts, which points towards the most extreme political abdication of responsibility and legally actionable criminal negligence, then the most explosive and uncontrollable public unrest may result.

We are appealing to you for visible responsible action to protect Malta; action guided by the observation that police are utterly powerless to stop the wave of unpredictable chaos in the rest of Europe. This is a time of opportunity for political leadership since only this can quell the rising tide of public distrust.

Our reason for concern is that the Supreme Court of South Africa recently forced the release of the **Vaccine Supply Contracts** into the public domain. The content is explosive in the context of public order because it proves that the public was lied to – at the cost of the lives of citizens.

The South African Pfizer-BioNTech supply contract was signed on 30th March 2021 - 3 months after Malta received its first batch of Covid vaccines from the same supplier with the following problematic clauses namely:

2.1 Agreement to Supply.

(b) Purchaser acknowledges and agrees that (i) Pfizer's efforts to develop and manufacture the Product **are aspirational in nature and subject to significant risks and uncertainties**

5.5 Purchaser Acknowledgement.

Purchaser acknowledges that the Vaccine and materials related to the Vaccine, and their components and constituent materials are being rapidly developed due to the emergency circumstances of the COVID-19 pandemic and will continue to be studied after the provision of the Vaccine to Purchaser under this Agreement. **Purchaser further acknowledges that the long-term effects and efficacy of the vaccines are not currently known and that there may be adverse effects of the Vaccine that are not currently known.**

It is assumed that Governments throughout the World including Malta have signed similar contracts. They have all in lockstep pronounced these 'Vaccines' to be 'safe and effective'. The Maltese public now requires visibility of the **Maltese Supply Contract**. Why this is now critical is due to the extremely concerning and ongoing excess deaths in Malta which are visible and undeniable since they are present even in the official European statistical site Eurostat. Below is Eurostat's graph of Maltese excess death from January 2023 through to October 2023.

The fact that Malta ranks highest in the excess mortality rate in the entire European Union should raise the most serious matter and we appeal for a Public Enquiry from our government as the current failure to address this major public health concern reflects negatively on our medical establishment.

Even the average level of EU excess death demonstrates a continuous post-vaccine public health emergency – and Malta’s level is double the average!

The current situation is a critical matter of national interest and is not a political issue, so we The Public expect support from all members of the government irrespective of party.

Malta’s situation is similar to that of countries like Australia, Canada, New Zealand, Japan, and Israel, which had the highest numbers of COVID-19-vaccinated people within their population. They too are experiencing similar crisis-level excess mortality.

Following public discussion and expert consultation, the conclusion is that this matter needs to be discussed urgently in parliament because it is clearly in the nation’s interest.

We would have expected the World Health Organisation (WHO) to raise the alarm and initiate an investigation into the alarming number of unexplained excess deaths that continue to occur well after the Covid pandemic has passed. The fact that the WHO gave such factually erroneous and public health-damaging advice from the outset, should be an indicator of their lack of trustworthiness.

The purpose of the COVID-19 vaccine was designed to achieve herd immunity, but due to excess deaths, it became blatantly obvious that herd immunity was never achieved.

Several international laboratories have reported their findings regarding the contents of the Moderna and Pfizer vials, and all found substances that were not present in the pre-trials for which the Food and Drug Administration (FDA) permitted an emergency roll-out.

Investigative laboratories discovered that Pfizer and Moderna left bacterial DNA (Plasmids) in the mRNA "vaccine" vials which were capable of transformation in bacterial cells. This DNA/mRNA would then be transported throughout the body by the carrier, the “lipid nano-particles” which are extremely

dangerous. One of the consequences of the presence of Plasmids (Bacterial DNA) is the presence of SV40 - a known cancer-promoting genetic sequence. The use of the term 'vaccine' by Pfizer and Moderna was to intentionally mislead the public. It is in fact a "Gene therapy" as it was called in the SCC findings of BioNtech and Moderna for which they had no licence. Dr. David E. Martin is taking the manufacturers of these so-called 'vaccines' to court accusing them of fraud, and Malta should be doing the same.

The amount of foreign DNA within the vaccinated should ideally be zero. The EMA and the FDA stated that limits for DNA contamination should not exceed 330 nanograms of DNA per milligram of RNA. However, tests found these to be 1,000 times higher, which could potentially cause serious bodily harm and death. This in itself is a criminal offense.

We would remind our government that the Maltese public through the propaganda by the mainstream media were told that the vaccines were 'safe and effective'. However from direct evidence of the supply contract, we now know that they were neither safe nor effective, and globally, evidence is becoming unassailable that they have caused serious health problems and mortality to the tune of at least 17 million deaths - and counting worldwide; all due to the Covid vaccine!

Yet no inquiry has ever been initiated or carried out.

As our elected representatives, we need you to take urgent action to ensure that we first, evaluate all of the above matters before we decide to agree and sign any agreement with the World Health Organisation (WHO) in the upcoming future, especially since they failed miserably to evaluate the grave consequences mentioned above due to their recommendations. Moreover, they have never taken responsibility for their actions.

Before Malta commits itself to any future agreement, we absolutely require that the cause of these excess deaths be fully investigated, since word is spreading fast that undeniable serious adverse effects from these COVID-19 vaccines are creating increasing anger and indignation among the population. We strongly request that you order appropriate investigative action with the highest priority. You have a duty before God to protect and defend our holy inheritance, to not allow selling out our health and our lives, our hard-earned self-governance, and our Trusts to enemies foreign or domestic for mere pieces of silver. You can also be complicit in these treasonous acts by doing nothing.

Political involvement should be understood to be inevitable - delay will only increase the risk to all and will be perceived to be an abdication of responsibility and criminal negligence.

The eyes and hopes of an expectant nation rest on you now.
