

EMAIL TO THE SPEAKER – 18TH APRIL 2024

Mr. Speaker,

Important Notice "Request For A Motion".

On Tuesday 16th April 2024, the majority of the Dutch Parliament voted in favor of the attached MOTION by Mona Keijzer and others, all members of the Dutch Parliament.

Concerns about the amendments to the International Health Regulations and the proposed new pandemic treaty have been brought to the attention of the Maltese Parliament, including members of the European Parliament and the President of Malta on several occasions.

The time to take action is now, due to the failure of the World Health Organisation to respect their regulations and processes, which cannot be ignored any longer as they are now in breach of international law. The citizens of the world are watching and countries are called to take action. Malta must not lag behind and be seen asleep at the wheel.

As you may be aware, Dr Chris Fearne was the President of the 76th World Health Assembly in May 2023 and will remain as such until a new President is appointed for the 77th World Health Assembly in May 2024. This irregularity should not happen under his watch.

The same motion needs to be urgently tabled on Monday in the Maltese Parliament to instruct our government to request a postponement of the vote on the amendments at the World Health Organisation in conjunction with the IHR and the new pandemic treaty at the World Health Assembly. This will give all member states the stipulated four months to evaluate the process. The responsibility lies with you to table this motion to postpone this process. However if not obtained, one must vote against the proposed amendments to the IHR and the new pandemic treaty. If the WHO ignores this request, inevitable legal measures will be taken.

Thank you in advance for your expeditious actions.

EMAIL TO THE SPEAKER – 1ST MAY 2024

Mr Speaker,

We do hope your sojourn in the Middle East proved a success?

Despite our best wishes for your travels, we are concerned that there has not been a single response to our emails? We spoke to Ancel on Monday to confirm receipt of the emails - we were saddened to learn of his recent loss of his father. We also spoke to the Clerk Ms Scerri.

A recent PQ regarding the Amendments to the International Health Regulations (IHR) to be considered at the 77th World Health Assembly starting May 27th this year, highlighted the failure of the World Health Organisation to meet their own standards in respect of this process.

Article 55 of the IHR REQUIRES the amendments to be shared at least 4 months before the World Health Assembly at which it will be considered. The decision A75(9) taken at the 75th World Health Assembly in 2022 (attached for ease), explicitly demands in (2)(f) for the working group to "...propose a package of targeted amendments, for consideration by the Seventy-seventh World Health Assembly, IN ACCORDANCE WITH Article 55 of the International Health Regulations (2005)."

These as yet unknown and undisclosed amendments will likely result in significant changes to the IHR - an international agreement that Malta is subject to and has been incorporated into law here. Malta cannot and should not ignore the provisions of the agreement.

We look forward to receiving your response.
