We invite you to respond to our previous letter of concern sent on 17th December 2024.

It is time to make an important political decision for the public good, as requested in our initial letter from NORTH Group¹. This letter has now been sent to the heads of state of 20 European countries, signed by nearly 700 international medical, scientific, and other professionals.

New Growing Evidence on DNA Contamination

We invite you to appraise new scientific evidence that extends upon that presented in our previous letter:

1. Results of a student research project completed under the supervision of FDA scientists and published in the Journal of High School Science showing that Pfizer mRNA vaccine vials contain residual DNA exceeding the safety limit by up to 470 times².
2. Analysis of raw data files from a peer reviewed publication that confirms that vaccine-derived DNA contamination is found within the blood of all recipients^{3,4,5}.

These findings necessitate immediate attention to ensure public safety and underscore the need for independent evaluation and open discussion. The risks posed to human health by vaccine-derived, LNP-encapsulated DNA are unknown, and may be extremely severe.

Numerous studies have confirmed side effects of mRNA vaccines, including heart conditions, blood clotting disorders, turbo cancer, diabetes, dementia, autoimmune disease, menstrual bleeding disorders, fertility problems etc. The contribution of residual DNA contamination to these confirmed side effects is not known and requires immediate attention and investigation.

Furthermore, with the imminent approval of a self-amplifying RNA vaccine⁶, for which detailed, and long-term safety studies are also lacking, it is high time to stop this human experimentation in the name of perceived technological development and profit and focus on scientific evidence and above all, safety. History will not look kindly on the oversight that is now occurring.

Our original letter included a request for evidence demonstrating that there is no risk of harm to human DNA from these vaccines. To date, no country has provided this evidence.

3. We kindly ask you to provide documentation supporting the claim that the permitted quantity of residual DNA in the modified mRNA vaccines as final products, including sequences derived from the SV40 virus in Pfizer's vaccine, do not compromise the genomic integrity of human cells.
4. We reiterate our call for:
 - An immediate halt to the use of mRNA vaccines and a recall of the product.



- An independent and transparent investigation into their approval and use.
- Scientific evidence proving that there is absolutely no risk of harm to human DNA.

We urge you to prioritize these critical issues and collaborate with independent experts to identify and mitigate potential risks associated with these vaccines. Such efforts are vital to strengthening public health systems, restoring public trust that has been lost since the COVID-19 response, and upholding the highest standards of scientific integrity.

Finally, we would like to bring your attention to the similar initiatives including the Hope Accord⁷, Australians Demand Answers/David Declaration⁸ and the Cape Byron Lighthouse Declaration⁹, these strong public initiatives exemplify the extent of the public concern that underlies them. Doctors and medical professionals across the board have been censored and denigrated for highlighting the systemic problems that have contributed to the regulatory failures and wider societal crisis that we are now facing¹⁰.

We look forward to your specific responses to the above points (1-4), as well as those contained in our previous letter of 25th November 2024, within 30 days so that we may continue this critical process together.
